HACKERS ARE INCREASINGLY TARGETING CRITICAL INFRASTRUCTURE

Verizon's recent security report from March 2016 indicates that Syrian hackers infiltrated an undisclosed water utility's control system and changed the chemical levels being used to treat tap water and made off with the personal information of over 2.5 million customers in the process. The breach transpired because the criminals were able to steal logon credentials for the utility's AS/400 mainframe that were stored on a front-end web server.

In 2011, hackers destroyed a pump used by an Illinois water utility after gaining access to the industrial control system it used to operate its machinery. This hack, like the one above, was also due to stolen user names and passwords and traced to cyber criminals in Russia.

On December 23, 2015, the Ukrainian Kyivoblenergo, a regional electricity distribution company, reported service outages to 225,000 customers. The outages were caused by illegal entry into the company's computer and SCADA systems and disconnecting substations. Keystroke loggers were used as part of the attack to steal system credentials. With regard to the Ukraine hack, DHS undersecretary for the National Protection and Programs Directorate (NPPD) Suzanne Spaulding says she hopes the NERC & SANS report will be a reality-check for US critical infrastructure owners. "I want ... [executives to say], 'what are we doing about this?'" to prevent similar attacks, she said during a February 2016 interview.
